

DO THE NEPHILIM EXIST?

The Nephilim are hybrid creatures described in the Bible, which were characterized by being the descendants of God's sons and human daughters as described in the Book of Genesis (Genesis 6:1-4. In the Book of Numbers (Num. 13:32-33) they are Nephilim described as giants inhabiting Canaan.

The Nephilim are mentioned in two places in the Old Testament. They are first



mentioned in the 6th Chapter of the Book of Genesis: "When people began to spread over the Earth and daughters were born, the sons of God saw that the daughters of the people had landed, and they took them as wives who wanted them." Then God Yahweh said: My spirit will not be in man forever, man is a physical being, but let his age be a hundred and twenty years. In those days, the earth was inhabited by the

Nephilim as a result of the procreation of the sons of God with the daughters of the people. They are the older, stronger people." After the mention of the Nephilim in the Bible, Noah and the general cosmic flood are further described. The second time the Nephilim appear is in the Book of Numbers, where they are described as giants.

The Nephilim are also mentioned in the apocryphal Book of the Prophet Enoch (Hen, 7:1-15), where they are also described as descendants of angels, sons of God and daughters of people. The names of the chief angels are further enumerated and it is noted that their leader was Samiasam. The women procreated with him and gave birth to the Nephilim giants, who were very tall and very hardy and eventually turned on the humans and ate them. Angels taught humans too many skills, but regardless, humans were on the verge of defeat. Then God sent his archangels, who fought with their exiled relatives and threw them into Hell. God sent destruction upon the earth in the form of a cosmic flood, but the giants became demons like their fathers.

There are four common aspects of Nephilim identity. The Nephilim were the children of angels and human women. According to this belief, sinful angels procreated with folk women and formed hybrid offspring on earth. The angels taught folk women various skills such as botany, magic, pharmacy. But when the descendants of the angels turned against the human race, the angels taught men the skills of forging weapons and warfare as well as the arts and sciences. It is this discovery of sciences inaccessible to humans and reproduction with them that is the reason why God expelled some of the angels from heaven. People were also punished, because God ordered a universal flood, but only Noah and his family were saved, to whom the archangel Uriel conveyed God's message about the imminent flood and the way of salvation. After this, God sent faithful archangels to deal with the fallen angels. From the giants and their descendants on earth arose a race of evil spirits. These ghosts became immaterial, bodiless beings who envied humans for their physical appearance, and therefore enjoyed torturing humans. These spirits gradually inhabited the bodies of people and assumed a physical form. From here to today is just a mental leap.



If the spiritual consequences of violence were treated the same as the consequences of physical violence, then we would soon realize that the world lives much more spiritually than physically injured. Soul injuries are deeper than physical injuries. Many research the consequences of environmental pollution, but only a few individuals delve into researching the consequences of spiritual environmental pollution. The world elite and the New World Order want to take complete control of the human race through their idea manipulation technologies.

Psychopathy is defined as a persistent disorder or condition that differs more or less from the average (psychopathic personality). Psychopaths are limited personalities in terms of mental health and illness mostly without intellectual impairment, even intellectually above average. The main changes in psychopaths are reflected on the emotional-volitional level of the personality. Today it is quite clear to a large number of people, at least to those who want it to be clear, that many world events are responsible for a small number of individuals, rich and powerful, outside the law, states and nations. Money is not a problem for them, because they are masters of sales and consumption and commanders of crises, poverty, hunger and wars.

If you look in this context of politics in the local political scene in general, it should be clear about what kind of profiles of people are found here. Our politicians are some kind of psychopaths who belong to the first, second and third groups. Only they, mainly because of their small size compared to their role models who rule at the top of the hierarchy, persist in their desire for power and have a tendency to gain more and more power. These are people who strive to achieve their goal at any cost. It is an uncompromising desire for money. When only they acquire money, it leads to saturation, which results in the fact that the money itself, which is obtained through theft, embezzlement, privatization, robbery and lies, is no longer sufficient. The desire for money and power, regardless of the damage to the nation, perfectly illustrates the example of uncompromisingly pushing the nation into certain integrations (e.g. the EU) so that psychopaths could, on this basis, enable success, power and authority over the entire population and their place in the luxury of the pathocracy and together with she enjoyed the blessing of power. Psychopaths admire immensely the power of the pathocracy and their method, because only in this way can they achieve the appropriate level of their rule.



Pathocracy is a form of government in which individuals with psychological disorders (primarily psychopathic disorders) occupy positions and rule in society and politics. This form of government stems from a

totalitarian system where rulers turn against their people. When these pathocratic psychopaths infiltrate any institution or country, the transformation of moral and ethical norms begins in a perverse way through various intrigues, which gain an increasing role and confirmation within such a society. Such norms and principles acquire an element of normality over time and become customary in society. Psychotic dogmas and principles become the normal standard of everyday life. These are things that would be irrational and psychopathic on any civilized level.

The global elite, which controls the world, made the decision a long time ago that the peoples of the world are subordinated to it, the 'working masses', to whom the elite has no responsibilities. The elite cares for themselves, and for the peoples of the world only as much as it suits their interests. A person is 'worthy' or has as much power as he has. To have means as much as to be. He who does not have is a nobody. Because the distribution of wealth is hugely asymmetric and a few percent of people own most of the world's wealth, most people are virtually without any social power. A handful of people of this world have humanity in their hands. She decides about everything and everyone, just as it suits her. The global elite serve themselves, and the peoples of the world serve them. This is an axiom.

The planet will become ever more turbulent and ever 'smaller', not only because of population growth, but even more so because of production and consumption growth. Limited natural resources, energy, raw materials and especially biomass, will become relatively rarer. Despite advances in science and technology, the struggle for survival may become more difficult than in the past for most of the world's population.

To some extent, the elite has transformed capitalism into an illegitimate and illegal predatory economy, especially through the monopolization and appropriation of public money, and in America even through the issuance of the national currency, the dollar, by a private issuing bank. Predatory economics is the natural enemy of the welfare state and the welfare state. Understandable, since the social services are a direct competitor to predators, who also collect from public funds. The free market would not recognize their participation in the added value to the predators, so they have to use state coercion to redistribute the social added value in their favor - at the expense of the social and general well-being of people.

The national elites, and consequently the global elite, do not intend to give up the predatory economy. To maintain and perhaps deepen an illegitimate predatory economy will require increasing internal repression to subjugate the disaffected masses, who will eventually become more and more aware



and will feel the privileges of the elite more and more unfair and a heavier burden. That is why the global elite invented the fight against terrorism. This is essentially a doctrine of pre-emptive defense against one's own people. Through the fight against terrorism, the elite gains leverage with which it creates mechanisms for more and more total control over people and their subjugation. The ultimate goal of the global elite is a 'world state' with a 'world government' under its leadership. The world state would be modeled after modern America, which, in addition to the leading financial oligarchy, is controlled by industrial, especially military-industrial, energy, biochemical, pharmaceutical, food and similar corporate oligarchies.

The global elite prepare scenarios for the future that suit them, not the people of the world. The interests of humanity are equated by the elite with their own interests. In the future, due to scientific and technological development, more and more people will become permanently 'technologically advanced'. Redundant workers become permanently unemployed, a kind of surplus people with whom no one shows solidarity. This is also why the global elite is thinking about depopulating the planet

under their leadership. He is thinking about soft methods of depopulation, such as shortening the life span, reducing the number of births, allowing starvation and death due to starvation, etc. But he also thinks about hard methods of depopulation through war and mass extermination of people.

The dominant media everywhere in the world carry out intense propaganda in terms of the interests of national and global elites. But the information monopoly of the elites began to crumble with the advent of the Internet and online media, which inform people even about matters that the elites keep silent or make different according to their interests. Therefore, the Internet elite is a thorn in the side and is thinking about how to limit its use.

Raising people's awareness is actually the only rational strategy in opposing the vampiric elites. Elites can carry out their secret agendas as long as no one but the authorized knows about them. When hidden agendas become public, the usurping and undemocratic nature of the elites quickly becomes clear. The decline of backward and socially dysfunctional elites in some Arab countries is largely due to the Internet and alternative information. Is a similar scenario also possible in the West?

The American elite in particular is intensively preparing for a clash with the people, both in terms of 'software' and 'hardware'. Legislation has been drafted that gives the president practically unlimited, dictatorial powers in the event of a state of emergency that the US president can impose himself. The US military and other government institutions, particularly FEMA, have plans already in place to subdue the population in the event of major civil unrest. They have already prepared camps for the mass deportation of people with a capacity of millions. Some Americans claim that many of them are equipped for extermination camps modeled after the German extermination camps. It should be equipped with gas cells.

Slovenia is also involved in global events, despite otherwise 'local specifics'. The transition from totalitarianism to democracy failed also for the reason that Western democracy is only an illusion and as such was never the real goal of the transition. The



latter was never what it was supposed to be, namely the transformation from a totalitarian to a democratic system. The power of (global) elites and democracy are two mutually exclusive concepts. Democracy is basically a capitalocracy or even a plutocracy - the rule of the rich. After Slovenia joined the EU and

other elite Western clubs, the global elite gave the domestic local elite a free hand to run the country in an undemocratic way, as democracy was never their goal. How (un)successfully the domestic elite, which has many characteristics of a predatory elite, runs the country and the national economy is its problem. The global elite adheres to the rule of (relative) non-interference in the internal affairs of local elites. What interests the global elite is that Slovenia is part of its 'global backyard', i.e. a predictable and controllable space in accordance with its global interests.
